Election Rules

For the MPFFU's 53rd Biennial Convention

- The reading and the adoption of these Election Rules shall be done no later than 4 pm on the afternoon of Tuesday, May 8, 2018 and will be immediately followed by the nominations for the office of MPFFU President, Secretary-Treasurer, District Vice Presidents and Trustees.
- For nominations for the office of President, Vice President, Secretary-Treasurer, and Trustee, there will be one nominating speech per candidate of no more than three (3) minutes. No second is needed. If there is only one candidate for an office, that candidate will be declared elected and his/her name will not appear on a ballot.
- 3. Individuals nominated for office must be a member in good standing of a Local Union which itself is an affiliated member in good standing of the MPFFU.
- 4. All Michigan Professional Fire Fighters Union officers who are delegates at large by virtue of their offices are eligible to participate in the nomination of candidates and the election of officers for the positions of President and Secretary-Treasurer and for the positions of Vice President and Trustee for the district or region their home local is located.
- If competing candidates are nominated for either the MPFFU President and/or the
 MPFFU Secretary-Treasurer position, each of the candidates will be permitted to
 address the Convention, at the conclusion of the nomination process, for fifteen
 (15) minutes with respect to their qualifications. Speaking order will be decided by
 Iot. Candidates for the office of Secretary-Treasurer will speak first.
- 6. Candidates must notify the Secretary-Treasurer, in writing, by 7:00pm on Tuesday, May 8, 2018 if they wish to withdraw from the election process. After 7:00pm on Tuesday, May 8, 2018, the ballots will be printed with the names of all duly nominated candidates appearing thereon, with a selection box next to the name of each candidate.
 - 7. One (1) ballot will be printed for each office and distributed to all qualified delegates containing the names of all duly nominated candidates who are proposed for each office: President, Secretary-Treasurer, District Vice President, and Trustee.
- 39 8. The Election shall proceed under the direction of the Election Committee. The

- election shall be conducted by a secret ballot vote of duly accredited delegates, or
 alternates replacing delegates, whose names appear on the list certified by the
 Credentials Committee's and accepted by the convention delegates.
- 9. Candidates for a contested office shall be permitted to appoint an observer to witness the balloting and also an observer to witness the tabulation of ballots. The names of the observers shall be submitted, in writing, to the Chairman of the Election Committee by 12pm on Wednesday, May 9, 2018 in the Convention office.

- 10. Election of all Officers shall be conducted on Wednesday, May 9, 2018. The exact time the that the polls shall open and close will be announced from the podium by the Election Chairman. It is anticipated that voting will begin at approximately 4:00pm and the polls will remain open until the announced closing time. Those standing in line at the announced closing time will be permitted to vote.
- 11. The official voting place will be in an area designated and announced by the
 Election Committee. THERE SHALL BE NO CAMPAIGNING WITHIN 50 FEET OF THE
 VOTING AREA.
- 12. Each delegate must identify him/herself with his/her convention badge to receive a
 ballot from a member of the Election Committee. As each delegate is given their
 ballot, his/her name shall be checked on the list of authorized delegates that was
 certified by the Credentials Committee and given to the Elections Committee.
- 13. Voting by proxy will only be permitted in accordance with Article 5, Section 5 of the
 Michigan Professional Fire Fighters Union Constitution and By-laws and if they were
 delivered to the MPFFU office or postmarked by April 27, 2018.
- 14. Proxy votes may only be cast for election of Officers, Convention Site Selection, and
 any roll call votes taken at the Convention.
- 15. If a local doesn't register the maximum number of delegates that it is entitled to, 71 the delegate registered as the Chairman of the delegation, in addition to his own 72 vote, shall cast the votes of any **unregistered** delegates the local was entitled to. 73 The Chairman of the delegation shall also be allowed to cast the vote of any 74 registered member of the delegation that left the convention prior to voting. It is 75 the responsibility of the Chairman of each local's delegation to inform the election 76 committee that he is voting for a registered delegate that has left. Once the ballot 77 for the absent delegate is given to the chairman of the delegation, the absent 78 delegate will not be able to receive a ballot if he/she returns during the time the 79 polls are open. Alternates for a local will not be permitted to receive a ballot 80 unless they have officially replaced a delegate and they present a delegate badge in 81

| 85 | placing a mark in the box next to the name of the candidate of his/her choice for |
| 86 | that office. A delegate may vote for not more than one (1) nominee for each office. |
| 87 | Only duly nominated candidates printed on the ballot may be voted for. Any write- |
| 88 | in candidate will invalidate the vote of such delegate for the office under which the |

 23. Ballots which are clearly void, or are questionable, shall not be tabulated and shall be placed in a separate receptacle for consideration and decision by the Election Committee. Ballots which are finally declared void shall be kept separate from the valid ballots and shall be tabulated separately as invalid ballots.

 24. Upon completion of the tabulation, the total vote for each candidate shall be placed
 132 next to his/her name on the pre-printed tabulation form for recording the
 133 tabulation of ballots.
- 25. Any objection or claim of irregularity following tabulation of the ballots shall be
 made to the Chairman of the Election Committee and ruled upon prior to the
 announcement of the results of the election.
- 26. If there is a tie vote or no candidate receives a majority of valid ballots cast on the 139 first ballot, all but the three leading candidates shall be dropped and the balloting 140 shall continue. If there were only three candidates on the first ballot and none 141 received a majority of the ballots cast, the lowest candidate shall be dropped and 142 the balloting will continue until one (1) candidate receives a majority of valid ballots 143 cast. There will be a minimum of thirty-minutes between each balloting. Additional 144 time may be required in order to complete the process of printing and copying new 145 ballots and delegate checkoff lists. If a tie vote occurs in the final ballot for any 146 office, one additional vote will take place. If a tie remains, the winning candidate 147 will be selected by the drawing of lots in the presence of both candidates. 148

- 27. Prior to announcing the voting results, the Chairman of the Election Committee shall make his/her report on any objections or claims of irregularity which have been raised. Any appeals to decisions made by the Election Committee must be made at this time. The Chairman of the Elections Committee shall then announce the results of the election. The presiding officer of the Convention shall then announce the results as official, final and conclusive.

 158 records to the MPFFU Secretary-Treasurer who shall retain them for one year and
 159 then destroy them by shredding them.
