Legislative Update for June 11th – June 15th

The legislature completed their work on Tuesday but passing more than 150 bills which included completing the FY 18-19 budget for the year. They will now begin their work in the district focusing on the elections.

Bill Introductions:

- [HB 6185 of 2018](#) Environmental protection; hazardous substances; firefighting foam containing PFAS; require reports on use of and require department of environmental quality to accept for disposal. Amends heading of subpt. 1 of pt. 147 of 1994 PA 451 (MCL 324.101 - 324.90106) & adds secs. 14701, 14703, 14705 & 14707.
- [HB 6186 of 2018](#) Law enforcement; fire personnel; use of firefighting foam containing certain substances; prohibit in firefighter training, and require certain training on use. Amends secs. 2 & 9 of 1966 PA 291 (MCL 29.362 & 29.369) & adds sec. 9c.
- [HB 6188 of 2018](#) Worker's compensation; disabilities; occupational cancer; extend presumption of causation to fire/crash rescue officers and forest fire officers. Amends sec. 405 of 1969 PA 317 (MCL 418.405).
- [HB 6198 of 2018](#) Labor; collective bargaining; obligation of bargaining representatives to represent public employees of local units of government in grievance proceedings; clarify. Amends sec. 11 of 1947 PA 336 (MCL 423.211).
- [HB 6203 of 2018](#) Crimes; assaultive; crime of assaulting a person performing job-related duties; expand to include health professionals and medical volunteers. Amends sec. 81d of 1931 PA 328 (MCL 750.81d).
- [HB 6204 of 2018](#) Criminal procedure; sentencing guidelines; sentencing guidelines for crime of assaulting or battering or endangering a health care professional or medical volunteer; provide for. Amends sec. 16d, ch. XVII of 1927 PA 175 (MCL 777.16d). TIE BAR WITH: HB 6203'18

- [SB 0929 of 2018](#) Health facilities; emergency medical services; ambulance availability for county or micropolitan area with population of 10,000 or less; provide for. Amends 1978 PA 368 (MCL 333.1101 - 333.25211) by adding sec. 20921b.
