The Michigan Legislatures "Lame Duck" session has officially begun. **The MPFFU legislative priority is HB 4688.** This is the bill that will make **staffing levels a mandatory subject of bargaining.** The bill will die if it isn't acted on by the end of this session. We believe we have support for the bill, but we are also competing with hundreds of other bills that also need to be voted on. Its possible it could be voted on as early as tomorrow, Nov 12th.

We don't ask you to do these things very often but this is your chance to assist the MPFFU and all of your brothers and sisters across the State.
